## Part-Time Kindergarten:

The above tuition rates are based on the Service Rate – to qualify for the Service Rate families agree to (1) purchase two auction tickets (cost of \$200.00), (2) sell two Golf Outing Raffle Tickets (cost of \$40.00) and (3) volunteer 20 hours of time per family at approved school functions. Any hours that are not completed by May 15, 2024, will be assessed a fee of \$25.00/hour.

K-8 Families that want to opt out of the Service Rate or pay the Non-Service Rate should add an additional \$1,000.00 to their tuition total.

## **Tuition Payment Options**

Tuition is collected through FACTS Tuition Management Company. These are electronic deductions from a checking or savings account, or a credit card (There is an additional 2.85% charge for credit card payments). The following are your tuition payment options:

- 11 payments July 2023 through May 2024
- 10 payments August 2023 through May 2024
- 9 payments September 2023 through May 2024
- Pay in full during July of 2023 with a 2% discount
- Pay ½ in July 2023 and the second ½ in November 2023 with a 1% discount

Tuition payments can be deducted on the 1<sup>st</sup>, 5<sup>th</sup>, 15<sup>th</sup>, or 20<sup>th</sup> of the month.

# Additional Fees (One time per school year)

- \$100.00 St. Mary Catholic School non-refundable registration fee for **new PK only families** (per family)
- \$100.00 St. Mary Catholic School non-refundable registration fee for current K-8 families (per family)
- \$500.00 St. Mary Catholic School non-refundable registration fee for **new K-8 families** (per family)
  - \$400.00 of the registration fee will be credited to the December K-8 tuition payment (This will not be credited towards preschool tuition). If a family pays in full, the \$400.00 will be credited to the tuition total.
- The FACTS Tuition Management set-up fees are as follows:
  - o 1 payment \$0.00
  - o 2 payments \$25.00
  - o 3+ payments \$53.00

Since the Fall of 2015, children must be 5 by September 1<sup>st</sup> to enter Kindergarten. This is a state law. Children turning 5 in September, October or November must demonstrate readiness as measured by the Brigance Test <u>AND</u> must have a St. Mary Social Readiness Assessment completed by the child's current preschool teacher. The decision to admit a child who is not 5 by September 1<sup>st</sup>, is determined at the discretion of St. Mary administration.

#### **Active Parishioner Tuition Status**

To qualify for the Active Parishioner Tuition rate, a family must be registered at an Archdiocese of Detroit Parish and worship regularly. You will need to have the "Active Parishioner" form signed by your pastor to qualify for this tuition rate.

To be considered an active parishioner at St. Mary Catholic Church a family must be registered in the parish and worship regularly. This will be monitored by greeting Fr. Paul (at least twice a month) after mass. This will be evaluated twice a year. If a family is listed as Active Parishioner and does not meet the above qualifications, their tuition will be changed to the Out of Parish rate.

# 4th/8th Grade iPad Fee

\*An iPad is required for all 4<sup>th</sup> through 8<sup>th</sup> grade students. A fee of \$500 (estimated cost – actual cost will be based on the cost of iPads at time of purchase) will be added to the middle school tuition for new middle school students to cover the cost of an iPad and a warranty on the iPad. This is a one-time fee. If you provide the iPad for your middle school student, no fee will be added.

### **Optional Costs**

#### St. Mary Catholic School Extended Care Hours

Morning "Extended Care" is available from 7:30 – 8:00 a.m. for a fee of \$2.00 per child.

Afternoon "Extended Care" is available from 3:15 – 6:00 p.m. for full days and from 12:00 – 5:00 p.m. for half days.

There is a \$25.00 yearly registration fee for every family that uses Extended Care. Afternoon Extended Care rates are \$7.50 per hour for families with one child and \$9.00 per hour for families with multiple children. There is also a \$5.00/month/student snack fee.

#### Lunch

The following are available at school: Hot lunch with milk for \$4.00; chocolate or white milk for .50¢; \$1.50 for an extra entrée.

## **Tuition Policy Overview**

For a family to qualify for an Active Parishioner tuition rate, they must be active parishioners in an Archdiocese of Detroit Parish.

For a family to qualify for the "Service" tuition rate, they must support the school through service (Auction/Golf Outing Raffle/Service Hours). The "Non-Service" tuition rate is the rate for those families who choose not to support the school through service (Auction/Golf Outing Raffle/Service Hours).

Tuition is due on the same day of each month. You may choose to have your payment deducted from your bank account on the 1<sup>st</sup>, 5<sup>th</sup>, 15<sup>th</sup>, or the 20<sup>th</sup> of each month. A finance charge of 1.5% will be added to accounts for payments received after your due date. There will be a \$25.00 charge for each check returned by our bank.

Tuition deposits are non-refundable. Tuition is non-refundable after February 1, 2024.

Tuition refunds (pro-rated) are given only if a family moves out of the area, or if for the child's welfare, the school recommends a change. Any family that **withdraws** their registration for the 2023-2024 school year after June 1, 2023, will be charged for the amount of books and supplies that have been ordered for that student. The materials will remain the property of St. Mary Catholic School.

### **Service Rate Tuition Details**

To qualify for "service rate" tuition, families must follow the listed three requirements:

(K-8 Families that want to opt out of the Service Rate or pay the Non-Service Rate should add an additional \$1,000.00 to their tuition total.)

## • Fundraising/Service #1

o Complete **twenty service hours** during the 2022-2023 school year. There will be a sign-up sheet at approved fundraising events that must be signed by the volunteer for the service hours to be applied. The school office will have a record of the service hours worked. Service hours must be approved by the school office and any hours that are not completed would be assessed a fee of \$25.00 per hour. Service hours should be completed by May 15, 2024.

## Fundraising/Service #2

 St. Mary has an annual Auction that is both festive and a lot of fun. Every service rate family is required to buy two Auction tickets (Total cost would be approximately \$200.00).

## Fundraising/Service #3

Sell/buy two raffle tickets for this event (Total cost would be approximately \$40.00).

#### **Archdiocese of Detroit Tuition Assistance Program**

Archdiocesan grants are available for Catholic families who are members of a Catholic parish within the Archdiocese of Detroit and have a demonstrated financial need. The qualifying child must be entering Kindergarten – Grade 12 at a Catholic elementary or high school within the Archdiocese. Families must apply for financial aid through the FACTS Management Grant & Aid Form by visiting the website <a href="https://online.factsmgt.com/aid">https://online.factsmgt.com/aid</a>. The application fee must be paid in order to complete the application process. Please be sure to include your applicant ID on all faxed or mailed correspondence.

## St. Mary Tuition Assistance

St. Mary Catholic School offers tuition assistance based on financial need. You must be a St. Mary parishioner and attend St. Mary Catholic School to be considered for an award. Any family with a student entering Kindergarten – Grade 8 that applied for financial aid through the FACTS Management Grant & Aid Form will be considered for St. Mary Tuition Assistance.
